



ALISTAIR ERSKINE MD MBA serves as the Chief Information and Digital Officer at Emory Healthcare and holds the title of Vice President for Digital Health at Emory University. Entrusted with the digital transformation of the Emory institution, Dr. Erskine leverages a strategic, platform-based, and experience-focused approach. He effectively manages a robust team of over 550 professionals dedicated to optimizing the experiences of patients, care teams, researchers, and ensuring the fiscal robustness of the establishment. His expertise encompasses the seamless integration of avant-garde technologies such as predictive, conversational, and generative AI into both clinical and administrative procedures.

Before joining Emory, Dr. Erskine distinguished himself as the Chief Digital Officer of Mass General Brigham, the esteemed teaching hospitals and clinics affiliated with Harvard Medical School. In this role, he spearheaded Mass General Brigham's Digital Health Strategy and Digital Health division, overseeing an expansive array of functionalities including the Electronic Health Record (eCare), Health Information Management/Interoperability, Virtual Care, and Data Analytics, directing a staff strength of over 650. His academic contributions are recognized with a faculty position at Harvard Medical School, where he imparts knowledge on clinical informatics and digital health to medical students, residents, and fellows.

Earlier in his career, Dr. Erskine was pivotal as the Chief Informatics Officer of Geisinger Health System, orchestrating the establishment of Geisinger's Unified Data Architecture, a sophisticated data management solution amalgamating Hadoop/Big Data with conventional relational database methodologies. Notably, he held the position of Associate Dean of Medical Informatics at Virginia Commonwealth University and served on the Board of the 650-physician-strong Medical College of Physician Practice Plan. Appointed to the Virginia Governor's Health Information Technology Commission, Dr. Erskine also played a decisive role as a voting member of the Health Information Technology Standards Committee. His global experiences include a two-year tenure in Doha, Qatar, where he assumed the role of Chief of Health Informatics at Sidra Medical and Research Center. A respected voice in the domain, Dr. Erskine frequently contributes to peer-reviewed journals and has the honor of serving on the boards of several publicly listed and nonprofit entities.

Educationally, Dr. Erskine is an alumnus of Brown University and Virginia Commonwealth University Health System. He is triply board-certified in Internal Medicine, Clinical Informatics, and Pediatrics. He further enhanced his academic credentials by completing a specialized two-year program at the prestigious MIT Sloan School of Management, focusing on Business Analytics and Artificial Intelligence.
