

## Responsible Conduct of Research Course: Fall 2025

### For Postdoctoral and Medical Research Fellows and Early Career Researchers

#### I. Course Overview

<p>1. Who should take this course?</p> <p>a. The Responsible Conduct of Research course is designed to satisfy ethics training requirements of federal agencies such as the NIH, NSF, and DOD, specifically for Postdocs, Medical Research Fellows, and Early Career Researchers.</p> <p>b. For example, those who:</p> <ol style="list-style-type: none"> <li>1. Have funding from individual federal <u>Fellowships such as NIH F32</u> or DOD Fellowships</li> <li>2. Are supported by <u>Training Grants such as T32 or K12</u></li> <li>3. Are funded by <u>K-type Career Development awards</u></li> </ol>
<p>2. What does this course look like?</p> <ul style="list-style-type: none"> <li>• Sessions will include presentations by faculty and discussion of topic-specific cases.</li> <li>• Readings, case study submission, and communications about the course will be available through Brainier.</li> </ul>

### IIIb. Assignments: Description

#### Postdocs and Medical Fellows

- Read the Background Information documents prior to class.
- Submit a Case for one of the topics to be discussed in each session.
  - Write a Case /Scenario (approximately 250 words – ½ page single space) of an ethical problem you have personally experienced, know of in other labs, or can imagine, that illustrates some of the principles in the Background Information document.
  - At the end of your case, write three questions that could be used in class discussions of the principle(s) illustrated in your case and could lead to recommendations for action or solutions to the problem(s) in the case study.
  - The case study is to be submitted as an upload to Brainier the evening before the classroom discussions (see due dates above).
- Complete the multiple-choice course review questions.

#### Faculty-rank Registrants

- Read the Background Information documents prior to class.
- Conduct two (one-hour each) discussions with graduate student(s) or Postdoc(s) using case studies and/or policies on
  - Authorship** AND
  - Mentorship**

A summary of the two mentoring/teaching sessions (~200 words each) is to be signed by the faculty person and trainee(s) and submitted by the end of the course to Brainier.
- Complete the multiple-choice course review questions.

## IV. Administrative policies

**Will I receive documentation of successful completion of the course?** To receive a certificate and verification from the Office of the Postdoctoral Education that the Ethics course was taken and completed as required by NIH, you are required to:

- 1) Submit all required assignments
- 2) Attend ALL discussion sessions
- 3) Submit the completed Final Course Review (“Final Quiz”) with a grade of at least 75%.

The Office of Postdoctoral Education will provide a description of the course that can be used in fellowship and grant applications.

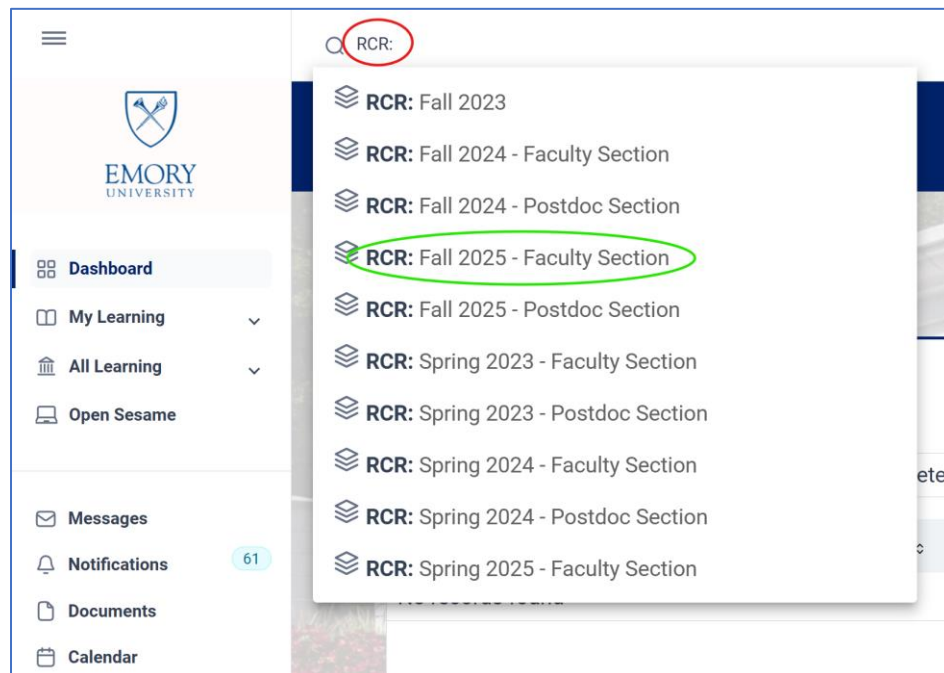
